Enrollment Requirements 2018-2019

- Completed Enrollment Packet** – Available either online or at each campus.

Open enrollment is from January 8, 2018 to February 21, 2018 at 4:00pm. Parents of the students accepted will be notified by email or phone after the end of the open enrollment period. Those students that applied during the open enrollment period but did not receive acceptance will be put into a lottery to determine their assigned wait list number. All future grade openings will be selected from this numbered wait list. Should openings occur after the initial wait-list has been exhausted, students applying after the Open Enrollment period will be placed in a new lottery to fill those additional grade openings.

After email notification, families will have 72 hours submit the following: (once school begins the deadline for submission will be 24 hours)

- Proof of Address** - Recent Utility Bill, Rent Receipt, Residence Lease or Sales Contract – Telephone bill or cable bills are not accepted.
- Your ID** - Personal identification of parent/guardian (driver's license, picture identification, etc.) bearing your name.
- Child's ID**
Please bring ONE of the following (photocopies will not be accepted):
 - Original birth certificate
 - Passport
 - Certified birth card issued by the Clark County Health District or another health district.
- Immunization Record** (Exemption Form located on DCS website or at each campus)
Up-to-date medical records indicating that your child has had, or at least started, the following series of immunizations:
 - Four DPT doses: 4th dose must be on or after the 4th birthday
 - Three Polio doses: 3rd dose must be on or after the 4th birthday
 - Two MMR doses: 1st dose must be after the 1st birthday. 1st and 2nd dose must be separated by at least 28 days.
 - Two Hepatitis A doses: 2nd dose must be given at least 6 months after the 1st dose. (Required for students new to Nevada or District after July 1, 2002.)
 - Three Hepatitis B doses: Must have a minimum of 4 months between 1st and 3rd dose and > 6 months old when 3rd dose was given. (Required for students new to Nevada or District after July 1, 2002.)
 - Two Chicken Pox (Varicella) doses: 1st dose on or after 1st birthday. 1st and 2nd dose must be separated by at least 28 days. (Required for students new to Nevada or District after July 1, 2011).
 - One Tdap dose: A child enrolling in 7th grade is required to have 1 Tdap (Bordetella Pertussis) dose.
 - One MCV4 dose: A child enrolling in 7th grade is required to have 1 MCV4 (Neisseria meningitides) on or after age 10, beginning June 30, 2017
